DISCIPLINE UNDER MEDICAL: PAEDIATRICS (COMMUNITY PAEDIATRICIAN)

MINIMUM REQUIREMENTS:

- i. Have completed a Structured Advanced Specialist Training (AST) **and** passed the Exit exam **or** attained Certificate of Completion of Advanced Specialist Training recognised by the Government of His Majesty the Sultan and Yang Di Pertuan of Brunei Darussalam (henceforth referred to as the Government of Brunei Darussalam) in the relevant disciplines.

OR

- ii. Becomes a member to the Royal College of Physicians/Surgeons (MRCP, MRCS, FRCAn, MRCOG MRCPeads) or its equivalent recognised by the Government of Brunei Darussalam **or** attained Professional Masters or its equivalent recognised by the Government of Brunei Darussalam **and** have completed Non-Structured AST, passed exit exam **and** have worked with the Government of Brunei Darussalam as Associate Specialist (Medical) at the salary scale of MD18 for not less than two (2) years.

OR

- iii. Becomes a member to the Royal College of Physicians/Surgeons (MRCP, MRCS, FRCAn, MRCOG MRCPeads) or its equivalent recognised by the Government of Brunei Darussalam **or** attained Professional Masters or its equivalent recognised by the Government of Brunei Darussalam **and** have completed Non-Structured AST, passed MOH Internal assessment **and** have worked with the Government of Brunei Darussalam as Associate Specialist (Medical) at the salary scale of MD18 for not less than four (4) year

OR

- iv. Have completed Non-Structured AST in the relevant disciplines recognised by the Government of Brunei Darussalam and passed MOH Internal assessment and have at least five (5) years of working experience at the level equivalent to a Specialist / Associate Consultant in a recognised training institutions.



ROLES AND RESPONSIBILITIES

1. Lead or / and be a member of a specialist team to carry out the assigned clinical (medical) services;
2. Provide delivery of medical services programs at the national level;
3. Managing the operation and co-ordination of medical services including providing insights to improve management effectiveness;
4. Active in international organisations such as the World Health Organization, ASEAN, APEC and other similar organisation;
5. Becomes a focal point for Brunei Darussalam for certain medical services programs in the international organisations such as the World Health Organization, ASEAN, APEC and other similar organisation;
6. Conduct studies and research on relevant medical services issues;
7. Prepare paperwork relevant to tasks and duties;
8. Review, provide recommendations, monitor and evaluate the policies of medical services;
9. Attend regional or international conferences, meetings or seminars to enhance professionalism;
10. Becomes an Advisor in developing medical education curriculum and becomes a Visiting Lecturer at any Medical Institutions recognized by the Government.
11. Involved in the planning and delivery of Specialist Training Program in Brunei Darussalam;
12. Provide advice, views and thoughts to top management at the Ministry of Health on specific matters in line with the areas of expertise and fields of works;
13. Carry out any tasks directed by the Head of Department.



WHAT IS EXPECTED:

- Support the core values of the Ministry.
- Have good communication skills and must be a team player.
- Be kind, caring and show empathy to patients and relatives.
- Be prepared to be assigned for work at any time and health facilities required by the service.
- Be familiar with Information Technology and comfortable using electronic clinical records.
- Keen to learn and have own initiatives for self-development (continuing medical education) and are required to show progression in own training within the employment period.
- Be involved in academic, research and audit activities.
- Be actively involved in training and teaching at all levels of undergraduate and post-graduate medical education.
- Be proactive and show enthusiasm and initiatives to develop and enhance the services.
