Syarat-Syarat Am:

- (A) Pemohon mempunyai pengetahuan kerasmian agama Islam, adat istiadat, kebudayaan, perkembangan social, ekonomi dan politik Negara Brunei Darussalam.
- (B) Bersedia untuk bertugas bila-bila masa di luar waktu bekerja biasa atau bekerja secara bergilir-gilir (*shift*) atau semasa cuti awam dan juga hendaklah bersedia untuk bertugas di mana-mana daerah di negara ini.
- (C) Bagi pemohon yang terdiri dari Pegawai-Pegawai Kerajaan hendaklah mempunyai tahap penilaian prestasi sekurang-kurangnya **SANGAT BAIK** bagi tempoh **tiga (03)** tahun kebelakangan.
- (D) Bagi pemohon yang terdiri daripada Rakyat Kebawah Duli Yang Maha Mulia Paduka Seri Baginda Sultan dan Yang Di-Pertuan Negara Brunei Darussalam, syarat mempunyai pengalaman kerja selama 5 tahun adalah dikecualikan.

KELAYAKAN MINIMUM:

1. Ijazah Sarjana Muda dalam bidang Kedokteran Veterinar / Sains Veterinar atau bidang bersesuaian.

5. Menjalankan proses siasatan kes diagnostik bagi penyakit haiwan di peringkat ladang dan makmal termasuk melalui siasatan epidemiologi, ujian sampel dan bedah siasat;
6. Bertanggungjawab dalam pemantauan pengurusan pusat-pusat penyembelihan yang diiktiraf halal di Negara Brunei Darussalam;
7. Mensyorkan, mengawal dan memantau penggunaan ubat-ubatan veterinar;
8. Bertanggungjawab merancang, menjalankan dan mengekalkan status bebas penyakit haiwan;



9. Berkemahiran dalam penyelesaian masalah dengan menilai situasi dan mampu membuat keputusan yang sewajarnya dengan cepat;

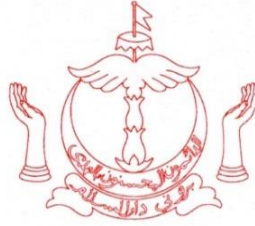

REQUIREMENTS:

1. Possess the Degree of Doctor of Veterinary Medicine OR Veterinary Science OR its equivalent and recognized by The Government of His Majesty the Sultan and Yang Di-Pertuan of Negara Brunei Darussalam.
2. Must possess at least 5 years working experiences in the management and care of animals particularly in relations to livestock with particular attention in matters of disease prevention.

DUTIES AND RESPONDIBILITIES

1. Responsible for research and provide advisory services regarding matters relating to animal health management, animal nutrition and animal diseases;
2. Plan, organize and implement National Livestock Health Programs;
3. Plan, organize and implement management of animal diseases including control and prevention, treatment and surgery;
4. Plan, organize and implement the development of the livestock industry in Brunei Darussalam;
5. Carry out diagnostic case investigation process for animal diseases at the farm and laboratory level through epidemiological investigations, sample testing and autopsy;
6. Responsible for planning, conducting and maintaining the disease-free status of animals;
7. Recommend, control and monitor the use of Veterinary Medicinal Products (VMPs);
8. Responsible for monitoring of the halal-recognized slaughterhouses management in Brunei Darussalam;



9. Sound clinical judgment and demonstrable ability to rapidly and accurately assess disease situations and apply the principles of scientific medicine in order to recommend and implement practical solutions;
10. Ready to deliver briefings and conduct educational courses and teaching technical skills to livestock entrepreneurs / farmers, students / staff work attachment and also to the public on matters of interest in the Department;
11. Maintain professional relationships and liaison with livestock operators, veterinarians, para-veterinarians, managers of food companies and others;
12. Extensive knowledge in the field of information technology (IT) for the work of preparing reports, briefings, information sharing and others that require IT skills;
13. Be prepared to work at any time outside normal working hours and shall be prepared to work anywhere in the country; and
14. Receive and perform duties or other instructions given from time to time by the Head of Office / Head of Division.
